A little move for the Spotlight Model this month to keep page two available for 'Other Things'. Rog Robbins's latest test flight was his new Extra from Probuild. Spanning about 1.7m (67") and running a DLE 30cc petrol engine with an 18x8 prop, it's a big model that is not short on power. Using Rog's own words, the first test flight "caused a bit of a panic until it was trimmed out". For those on our Facebook group, there's a video of it's second test flight (shot by some dodgy amatuer) to give you an idea of this model's performance. Getting his next model in early, Rog also has a Keil

Kraft Caprice in the works, currently waiting for a clockwork D/T. (Free flight speak for 'Something to make it come down').

Gareth kicked off this month's meeting by handing out some sheets with a summary of the BMFA update about DRES and how it will work. This certainly kicked off some discussion about Operator/Flyer IDs and how it works for minors (under 18).

Told you there'd be a White Elephant!

Click on the 'About registration' link and read that page, it does explain things quite well.

As I have quite a lot of time and very little brain, here is a, hopefully useful, explanation of the relevant bits.

Basically, if you fly something heavier than 250g, it's going to cost someone £9 a year.

The Operator, who must be over 18, is the person responsible for the model and must only allow someone with a Flyer ID to fly it.

The Flyer is responsible for ensuring the model is flown legally. On a buddy box, the Instructor is the Flyer, the Student isn't.

Anyone over 18 that flys their own models will need to register as an Operator and a Flyer.

Anyone under 18 that flys their own models will need to register as a Flyer. If they are under 13, a parent/guardian must be present when they register. Additionally, a parent/guardian will need to register as the Operator or Non-Flying Operator of the models.

To register as an Operator, you must register and pay $\pounds 9$. You will receive an Operator ID which must go on all the models you are responsible for. This registration lasts for 1 year.

To register as a Flyer you must register and pass the - apparently reasonably easy - CAA competency test or the BMFA RCC (see below), or hold an A-cert or equivalent. You will receive a Flyer ID which you should carry when you are flying. It is free and the registration lasts for 3 years.

Hopefully that explains the Operator and Flyer thing, it seemed to create some confusion. Most of us will be Operators and Flyers and, as BMFA members, we can choose to let the BMFA handle the registration when we renew our membership. Those without an A-cert can take the BMFA's own 'Registration Competency Certificate' (RCC) as part of the membership renewal process.
